## INSTRUCTIONS

After the tax bills are prepared, the county clerk must complete four copies of this receipt showing the amount of taxes due each taxing district. The sheriff must complete the acknowledgment and sign all four copies in the presence of the county clerk. Submit the original to the Office of Property Valuation, P. O. Box 1202, Frankfort, Kentucky 40602-1202 with two copies of the County Clerk's Claim for Preparing Tax Bills, Revenue Form 62A363. Forward the second copy to the county judge-executive, deliver the third copy to the sheriff and retain the fourth copy to be made a part of the court record.
