INSTRUCTIONS

Prepare this receipt in quadruplicate. The sheriff must complete the acknowledgement and sign all four copies. The county clerk shall maintain the original, one copy to the sheriff, the property valuation administrator shall retain one copy and the other copy shall be forwarded to the Department of Revenue, Office of Property Valuation, P.O. Box 1202, Frankfort, Kentucky, 40602-1202.

The property valuation administrator shall prepare Form 62A367 instructing the county clerk to prepare additional and/or supplemental tax bills. Additional and supplemental tax bills shall be prepared by the clerk. The clerk shall complete Form 62A386 for the total of taxes due each taxing district and give the bills to the sheriff for collection after he signs the four copies of the receipt.
