Re: Kentucky's 2025 SSUTA Compliance Recertification

Dear Mr. Johnson:

Pursuant to Section 803 of the Streamlined Sales and Use Tax Agreement ("Agreement") and Rule 803.1, on behalf of the commonwealth of Kentucky, a Streamlined Sales Tax Governing Board member, and as the Commissioner of the KY Department of Revenue, I hereby certify to the Streamlined Sales Tax Governing Board that Kentucky is in substantial compliance with the terms of the Agreement as of July 1, 2025.

No changes have been made to Kentucky's statutes, rules, regulations, or other authorities that could affect our compliance with the terms of the Agreement since July 1, 2024.


There was an enactment from the 2025 legislative session that created a sales and use tax exemption for bullion and collectible coinage, effective March 27, 2025, and retroactive to August 1, 2024. We have posted this information on our website ([Sales and Use Tax Paid for Purchases of Bullion and Collectible Currency](#)) and submitted the corresponding Form TC0001 to the CSPs. Test decks have been submitted and approved accordingly.

As part of this annual recertification, Kentucky has updated its Online Certificate of Compliance and Taxability Matrix (Part 1 – Library of Definitions and Part 2 – Tax Administration Practices), which reflect Kentucky's laws enacted through August 1, 2025, and has approved them to be published on the Streamlined Sales Tax Governing Board website beginning July 24, 2025.
