## INSTRUCTIONS

The outgoing sheriff shall take a receipt (62A385-A) from the incoming sheriff for the unpaid and partially paid tax bills. The receipt shall be signed and acknowledged by the incoming sheriff before the county clerk, filed in the county court and recorded in the order book of the county court in the manner required by law for recording the official bond of the sheriff.

The outgoing sheriff must complete five copies of Sheriff's Official Receipt for Unpaid and Partially Paid Tax Bills (62A385-A). He must submit the original to the Office of Property Valuation, P. O. Box 1727, Frankfort, Kentucky 40602-1727, forward the second copy to the county judge-executive and deliver the third copy to the county clerk to be made a part of the court record. The outgoing sheriff and the incoming sheriff should each retain a copy of the receipt.
