## **EXPLANATION OF RATE TABLES**

**This publication reports the 2019 & 2018 ad valorem property tax rates of the local governmental units in Kentucky, including county, city, school and special district levies.**

**Non-historic motor vehicles are subject to full state and local taxation in Kentucky. Historic motor vehicles are subject to state taxation only. The state tax rate for non-historic vehicles is 45 cents per \$100 of value. The state tax rate for historic motor vehicles is 25 cents per \$100 of value.**
