MyTaxes is Now Available

The new business tax portal, MyTaxes.ky.gov, is now available. The following taxes can be found in MyTaxes:

Sales & Use, Corporation Income (Corp)/Limited Liability Entity (LLE), Telecom, Withholding, Utilities Gross Receipts License Tax (UGRLT), Non-Resident Withholding (NRWH), Commercial Mobile Radio Service (CMRS), Tire and Transient.

Use this information to log in to MyTaxes and create a new password if you have not already completed this step. Maintain your login information and keep it secure for future use. **Do not share or forward this email.**

*Note, you will need to type in your username manually – copy and paste will not work.

Steps to Log In to MyTaxes

You are considered a “migrated user” of MyTaxes. We have migrated your user account to maintain your previous access and associated (linked) businesses. You will have to perform an additional sign-in step the first time you log in to MyTaxes.

1. Visit MyTaxes.ky.gov and click the “Log In Now” button.
2. Enter your username and click the “Next” button.
3. The next screen says, “Verify it’s you...” Be sure to click “Password.”
4. On the next screen, click the “Forgot Password/Not Provided” link the first time you log in to MyTaxes.
5. Click “Send me an email” to receive a code to reset your password.

6. You will receive an email with a code. Click the reset password link in the email or go to MyTaxes and enter the code to receive a prompt to create a new password.
7. Create a new password to complete the password reset process.
8. To continue signing in, click the “Send me an email” button and navigate to your email to retrieve the one-time verification code, or use the “Sign in” button in the email.
9. Complete the verification process to reach the MyTaxes dashboard.

You will not need to use the “Forgot Password/Not Provided” link the next time you log in unless you have forgotten your password. However, to enhance security, you will go through a multi-step verification each time you log in.
