



Important Updates to How You File Your Business Taxes

The Kentucky Department of Revenue (KY DOR) is continuing a multi-year upgrade to our tax system to improve data security and provide faster and more efficient customer service.

Our records show that you pay one or more of the following tax types:

- Rental Rideshare
- Sports Wagering
- Electric Vehicle Power (EVP)

Beginning August 14, 2026, Rental Rideshare, Sports Wagering, and Electric Vehicle Power (EVP) tax types will be accessed through MyTaxes to enhance your filing experience with built-in calculations, improved accuracy, and easier access to your historical records.

If You Have Used MyTaxes Previously

If you have used MyTaxes before for other tax types, simply log in as usual. Beginning August 14, 2026, Rental Rideshare, Sports Wagering and EVP taxes will be available within your MyTaxes account. You will need to log in to your MyTaxes account and link your business to access these records.

If You Have Not Used MyTaxes Previously

If you have not previously used MyTaxes but have filed these tax types electronically, you will use the same login information to log into MyTaxes. You will access Rental Rideshare, Sports Wagering and EVP taxes through MyTaxes, starting August 14, 2026. Visit the [KY DOR Taxes Dashboard](#) and click on the MyTaxes tile to get started.

You will need to log in to your MyTaxes account and link your business to access these records.

KY DOR Temporary Operations Pause

KY DOR will temporarily pause operations during this next phase of our tax system update from August 5-13, 2026. During this time, KY DOR systems and online tax portals, including MyTaxes, will be unavailable. KY DOR staff will only be able to provide limited assistance, as they will not have access to view taxpayer information. KY DOR intends to resume normal operations on Friday, August 14, 2026.
