APPLICABLE PENALTIES

Any county clerk who violates any of the provision of [KRS 142.010](#) shall be subject to the uniform civil penalties imposed pursuant to KRS 131.180.

[KRS 131.180\(1\)](#) imposes a penalty of 2 percent of the fee, up to a maximum of 20 percent of the fee for each 30 days or fraction thereof that the report is filed late. In no case shall the penalty be less than \$10.

[KRS 131.180\(2\)](#) imposes a penalty of 2 percent of the fee, up to a maximum of 20 percent of the fee for each 30 days or fraction thereof for failure to pay at least 75 percent of the fee by the due date. In no case shall the penalty be less than \$10.
