



### Motor Fuels Tax E-File EDI VALIDATION

### A. General Information

This document defines the validations used by the Kentucky Motor Fuels Tax E-File system to identify errors when processing an EDI file received from a taxpayer. EDI data transmitted by a taxpayer does not constitute a legal tax return. Only after the data has been accepted by the system with no critical errors does it become a return that can be submitted by the filer. Until it is submitted it can be removed by the filer. Therefore, the filer must submit their returns to be considered received by the Kentucky Department of Revenue. If the errors are not corrected, a tax return will not be produced for submission and payment to the Commonwealth of Kentucky.

The table below only lists the validation rules that create the following Critical errors types:

- Critical High Level 1 errors must be corrected before the EDI file can continue processing to identify the Critical High Level 2 errors
- Critical High Level 2 errors must be corrected before the system creates the tax return
