State Real Property Tax Rate is Unchanged

The 2005 state real property tax rate has been set at 13.1 cents per \$100 of assessed valuation. Since the enactment of House Bill 44 in 1979, the rate is reviewed each year and adjusted to ensure that no more than a 4 percent cumulative increase in revenue is realized over the previous year. The increase for 2005 is estimated at 3.63 percent; therefore the 2004 rate of 13.1 cents per \$100 remains unchanged for 2005.



The establishment of the 2005 state real property tax rate enables those counties certified by the Department of Revenue (DOR) to proceed with tax bill preparation once the local property tax rates are set.

McQueary Named New Executive Director



Gov. Ernie Fletcher has named Garrard County Property Valuation Administrator (PVA) Marsha McQueary to the position of Executive Director of the DOR's Office of Property Valuation. McQueary's appointment was announced by Deputy Commissioner Marian Davis at the PVA Summer Conference in Louisville on June 22. McQueary replaces Davis, who was appointed Deputy Commissioner of the DOR in April.

McQueary had served as PVA in Garrard County since 1996. Prior to being elected to that position as a write-in candidate, she had worked for 18 years as a deputy under former Garrard County PVA, Harvey Howard. McQueary is a Certified Residential Real Property Appraiser and holds the Senior Kentucky Assessor (SKA) professional designation.

A special examination for residents of Garrard County interested in serving the remainder of the 2002-06 term of PVA was held Wednesday, July 13, at the DOR's office in Frankfort. Six of the seven candidates who took the exam passed.

Governor Appoints New PVA in Garrard County



Gov. Ernie Fletcher has appointed David Land as PVA in Garrard County. Land replaces Marsha McQueary, who left in June to accept the position of Executive Director of the Office of Property Valuation. Land is a residential real estate appraiser for Blake and Associates in Richmond and also owns his own business, David Land Tax Service. His appointment was effective Aug. 1, 2005. He will serve the remainder of McQueary's term, which expires at the end of 2006.

New Web Site Presented at Summer Conference

The new *PVA Network* Web site was unveiled at the 2005 summer conference. This site contains a wealth of information to assist PVAs in their duties. It has links to the three branches of the Office of Property Valuation (State Valuation, Local Valuation, and Minerals Taxation and GIS Services), as well as to the PVA Administrative Support Branch.



Documents relating to the education program, such as the course schedule, forms, and the *Student Manual* are available on *PVA Network*. One new feature that will help students get off to a good start is the *First Day Class Reading Assignments* area. A *Conference Information* area will provide updates as

available and a direct link to the conference hotel, the Galt House. The site has numerous links to assist Tax Roll Information Management (TRIM) users, including E-mail, Purchasing, Security and the Wide Area Network (WAN). The *Current Itinerary* for the field representatives is also featured on the site, to assist PVAs in locating their representatives without calling Frankfort. The Web site is updated often, so be sure to check regularly for new information and updates.

PVA Network also has a link to the PVA Administrative Support Branch page on the Office of the Controller's Division of Local Government Services Web site. This site contains personnel forms, the PVA Fiscal and Personnel Manual, and links to other helpful sites, including Social Security.

Russell and Bracken counties are the latest to join the state's WAN. This brings the total to 106 counties connected to the WAN.



PVAs and deputies using the WAN should also be aware of a change involving e-mail. Microsoft is ending support for Microsoft Exchange 5.5, the software that currently runs all state e-mail. As of Dec. 31, 2005, the Commonwealth Office of Technology will be migrating to Exchange 2003 in a planned but very short timeline. Payroll deduction forms were recently sent to all PVA offices, along with an informational brochure outlining the six participating charities. Payroll deduction is the most popular method of giving. Contributions may also be made with cash or check, which must accompany the pledge form. Persons submitting payroll deduction forms electing at least the minimum \$2 per payroll deduction, or making a cash contribution of at least \$48 no later than Oct. 14, are eligible for a drawing for a 2005 Derby Breakfast print signed by Gov. Ernie Fletcher.

IAAO Selects Louisville for 2009

On Sunday, Aug. 8, 2005, the Executive Board of the IAAO selected Louisville, Kentucky, to be the host city for the International Conference on Assessment Administration, to be held in October of 2009. This event has been held only once before in Louisville, in 1981. Cities in 18 states and three Canadian provinces in central North America were eligible for this honor. In April, the list was narrowed to three cities: Calgary, Kansas City and Louisville. The Executive Board eventually chose Louisville based on its competitive cost and the efforts of the award-winning Kentucky Chapter of IAAO.

The economic impact of this event will be significant, with over 1,500 property tax professionals from around the world attending for four to five days in downtown Louisville. Kentucky PVAs and DOR employees will enjoy accessibility to the benefits of conference attendance without having to spend thousands of dollars on airline fares and car rentals. This year's IAAO Conference is in Anchorage, Alaska.

News from the PVA Administrative Support Branch

The summer has been very busy for the PVA Administrative Support Branch. Beverly Stone joined the Branch on July 5 as a Personnel Management Specialist Officer. She previously worked in the Department for Public Health and will be working with Adair-Clinton, as well as Franklin-Graves counties.

The Governor's Wage Equity Program (GWEP), along with the new salary schedule, became effective on July 1. The annual increment for FY 2005-06 will be 3 percent for all state employees.

Open enrollment for health insurance will be October 17–28. There are several changes for this year, the biggest being online enrollment. Employees will be able to enroll themselves, on the Internet, and immediately know that everything is changed for next year. You may also change your personal information and add, change or delete coverage of your dependents.

Deputy PVAs who earn their CKA or SKA professional designations receive a one-time lump-sum payment based on their salary at the time of the award. Due to the temporary lifting of the freeze on education awards to deputies receiving CKA and SKA designations, the PVA Administrative Support Branch processed 10 checks for deputies earning their designations during the recently ended fiscal year. All deputy PVAs are encouraged to continue to attend classes and work toward these designations. Approval of more education awards by the PVA Association Budget Committee is anticipated for next year at the PVA Summer Conference.

Long-Time Department Employees Retire



Bruce “Doc” Halliday, Ph.D., retired after 27 years of service on July 31. Halliday started working for the DOR in 1979 in the Research Division, then transferred to the Office of Revenue Estimating as an economist. He joined the staff of the Department of Property Taxation in 1982 working for the Division of Technical Support. His position was moved to the Division of Research (back where he began) in 2000. His most prominent duty was calculating the state real property tax rate each year and the homestead exemption amount every other year. He also assisted in the determination of revenue impacts of proposed legislation and provided support for the Consensus Forecasting Group.

Halliday has a bachelor’s degree from Ohio State and a master’s and Ph.D. from Kent State in Ohio. Before he joined the DOR, he was an assistant professor at Kentucky State University and worked for the Economic Development Cabinet for a year.

Halliday was honored at a retirement reception along with several other DOR employees July 13. He plans to spend his retirement working on his property and spending time with his three grandchildren.

Bob Smith, a property assessment coordinator with the Southern Field Branch for over 30 years, also retired July 31. Smith had a long and varied career both within and outside of state government. After graduating from Morehead State University with a degree in Business Administration, he began teaching school on an emergency certificate and spent the next three years earning his teaching certificate during the summers and teaching high school in Knott County.

In 1969 he ran and won election for the office of PVA in Knott County. Things were quite different in the office then; Smith and his one deputy had to do everything by hand, including looking up values for all the vehicles in the county. He resigned as PVA in Oct. 1972 to come to work for the DOR, where he worked until his retirement. Serving as PVA prepared him for most of the work he encountered as a “field rep.”

In addition to working as a teacher, PVA and then as a field representative, Smith also owned a drive-in theater.

Smith was honored at a luncheon attended by members of the Southern Field Branch Thursday, Aug. 18.
