Attention Lewis County residents: a special examination of prospective candidates for the office of Lewis County Property Valuation Administrator (PVA) will be conducted at KACo Building, 400 Englewood Drive, Frankfort, KY, on Friday, May 11, 2018, at 9:00 a.m. EST. This examination is open to Lewis County residents only. Identification will be required.

Qualified persons who pass the examination will be eligible for appointment by the Governor to serve as interim PVA for the remainder of the term.

In addition, the executive committee of each party may nominate a qualified candidate for placement on the November 6, 2018 general election and qualified independent and political organization/group candidates may be nominated by petition.

PRE-REGISTRATION IS REQUESTED, BUT NOT REQUIRED, FOR THIS EXAM. PRE-REGISTRATION DEADLINE IS MAY 4, 2018. SEATING WILL BE ON A FIRST COME FIRST SERVE BASIS. YOU HAVE THREE (3) WAYS TO PRE-REGISTER FOR THIS EXAM:

Applicants must be at least 24 years of age, a citizen of Kentucky, and have resided in the state two years and in Lewis County at least one year preceding the appointment or election. The examination is based on verbal and mathematical skills, and consists of written testing. All materials necessary to take the examination, including calculators, are supplied.

Kentucky Revised Statute 132.380(1) states in part:

"Before any person's name shall appear before the voters on election day as a candidate for the office of property valuation administrator in any primary or general election, except as a candidate to succeed himself in office,... he shall hold a certificate issued by the department, showing that he has been examined by it and that he is qualified for the office."

Kentucky Revised Statute 132.370 (2) states in part:

Property Valuation Administrators shall possess the qualifications required by Section 100 of the Constitution and by KRS 132.380 and shall be eligible for re-election.

Section 100 of the Constitution of Kentucky requires that applicants must be:

- at least 24 years of age at the time of the election
- a citizen of Kentucky,
- and have resided in the state for at least two years, and in the county at least one year preceding the election.

Applicant identification will be required prior to taking the examination. A driver's license or other ID with recent picture will be required as evidence of identification.
