PVA RELATED ISSUES

- 2010 -04 (September 27, 2010) May a deputy PVA co-own a real estate brokerage business with a partner who conducts business in the county in which the deputy PVA is employed? Only if the deputy PVA does not financially benefit from the partner conducting business in that county.
- 2009 – 14 (March 27, 2009) Is it a conflict of interest for a Property Valuation Administrator or a deputy Property Valuation Administrator to own real property in the county in which he or she is employed? – No, within limitations.
- 2007 - 36 (October 19, 2007) May PVA field rep. work privately as an appraiser in his own county? Amends Advisory Op 07-25 Yes, if data collected as a part of official duty is not used for PVA appraisal of a property on which he performs a private appraisal; however an appearance of conflict may still exist.
- 2007 - 30 (August 24, 2007) May PVA serve on local boards of directors? Yes
- 2007 – 26 (October 19, 2007) May a PVA employee who is also a licensed realtor accept referral fees? Yes, within limitations.
- 2007 – 25 (August 24, 2007) May PVA field representative work privately as appraiser in his own county? Yes, if data collected as a part of official duty is not used for PVA appraisal; appearance of a conflict may still exist.
- 2007 – 19 (June 29, 2007) Review of Nepotism under the Executive Branch Code of Ethics (Amends Advisory Opinion 04-34)
- 2006 – 29 (December 15, 2006) Spouse of PVA as RE Agent - Yes
- 2005 – 27 (May 27, 2005) Accept Travel Expense Reimbursement from Professional Association – Yes (Enc. 1993-49, 95-29, 2002-30 & 03-11)
